



Tips for Estimated Metropolitan Commuter Transportation Mobility Tax

Did you know? You can pay your estimated metropolitan commuter transportation mobility tax (MCTMT) electronically on our Web site with a debit from your checking or savings account. Visit us on the Web at www.nystax.gov to pay your estimated MCTMT electronically instead of using Form MTA-5.

To help us match your estimated MCTMT account to your MCTMT return, and to avoid a delay in processing your return, please note the following:

- **Social security number/taxpayer identification number** — Make sure that the social security number used on your vouchers agrees with the number on your social security card and the number used on your MCTMT return. If you use a taxpayer identification number, this number must agree with the number used on your MCTMT return.

- **Name** — Make sure that your name is spelled correctly. You should enter your first name, middle initial, then last name in the spaces provided (for example, *John O. Smith*). Your name **must** agree with the name on your MCTMT return.
- **Foreign addresses** — Enter the information in the following order: city, province or state, and then country (all in the *City, village, or post office box*). Follow the country's practice for entering the postal code. **Do not abbreviate the country name.**
- **Married taxpayers** — If both spouses owe the MCTMT, each spouse must establish a separate estimated MCTMT account.

Do not combine any payment of estimated MCTMT with any payment of estimated personal income tax. The addresses and due dates for MCTMT are different.

Do not staple or clip the check or money order to the voucher. Please detach any check stubs before mailing.
